EMMIE PW 00025 was written based on estimated amounts reflecting 0% completion; no actual documentation had been submitted. This amendment is written to reflect actual submitted documentation covering 90% of total anticipated debris removal activity. The remaining 10% has been estimated based on costs associated with completed work.

**AMENDED DAMAGE DESCRIPTION AND DIMENSIONS**

Hurricane Sandy deposited vegetative debris, Construction and Demolition (C&D) debris, White Goods, and Sand throughout Union Beach Borough requiring immediate removal because it posed an immediate threat to lives, public health and safety, and improved property. This project worksheet addresses the debris that the applicant removed from applicant owned and maintained public property and their maintained public rights-of-way.

**SCOPE OF WORK**

**Work Completed:**

**Loading/Hauling:** During the period of November 4 to December 21, 2012, the Borough hired Sakoutis Brothers; Devco Building and Construction; Apollo Excavation; Aurora Environmental Inc.; B&B Paving; 3C's Backhoe Service; M&S Waste Services; and Freehold Carriage Inc to remove debris throughout the Borough. These contractors hauled and processed 550 tons of vegetative debris and 9,727.66 tons of mixed C&D.

**Monitoring:** The Borough hired O'Brien Response Management (O'Brien) to monitor the debris operations of Sakoutis Brothers Disposal at both the pick-up site and the temporary staging site. The Director of the Department Public Works, John K. Haines CPWN, CRP, was responsible for monitoring the activities of the contractors hired by the DPW. The contractors hired by the DPW completed their debris removal work at the end of December. A new contract for debris removal was awarded to R&B Debris LLC. O'Brien will monitor all debris removal activities to the end of the mission.

**Consulting:** The Borough hired T&M Associates as consulting Engineers to prepare bids, hire contractors, and oversee debris removal operations. They also hired Witt and Associates to provide professional administration services.

**Temporary Staging Area (see permits attached):** The C&D and White Goods are being taken to three Borough owned temporary staging areas: (1) Front and Dock Street (40.45445, -74.17494); (2) Scholer Park Parking Lot located on Spruce and Prospect St.(40.447339, -74.171312); and (3) IFF Parking Lot at 800 Rose Lane (40.445564, -74.156432) where it is being separated. The vegetative debris is being taken directly to a disposal site.

**Final Disposal:** The vegetative debris is being hauled to Monmouth County Reclamation Center for final disposal. The C&D and White Goods are being hauled to either Mazza and Sons Demolition and Recycling at 3230 Shafto Road, Tinton Falls, NJ. (GPS 40.229217, -74.108041) or Montecalvo Disposal Services Inc. at 75 Crows Mill Road, Keasby, NJ (GPS: 40.514841, -74.309123) for final disposal. The Sand removed from the storm water drainage system by Russell Reid Company will be taken to an unnamed, approved waste disposal facility. The recaptured sand will not be returned to beaches.

The costs for the work completed are based on actual review of documentation. The quantities for the work completed are based on actual review of documentation.

**Work To Be Completed:**

**Loading/Hauling:** The estimated disaster-generated debris remaining to be hauled includes an estimated 7,500 CY of mixed C&D in homes that have not yet brought all their eligible debris to curbside; 100 tons of eligible sand debris blocking storm sewers; and an estimated 5,000 CY of debris still in Borough streams and marshland. On December 13, 2012, pursuant to the Borough's procurement policies, they contracted with R&B Debris LLC of Hainesport NJ, the low bidder, to continue the debris removal loading and hauling; and with Russell Reid of Keasby, NJ to remove sand debris

from the Borough's storm water drainage system. Force account labor and equipment will also continue to be utilized to complete the remaining debris operations. The costs for the work to be completed are based on estimates derived from contracted rates for this type of debris. The quantities for the work to be completed are based on estimates derived by determining the following:

- 250 remaining homes marked for demolition are estimated to have 30 CY each of eligible household debris that will be placed curbside for the Borough to collect and remove. The 30 CY yard value was found in FEMA 329 Field Estimating Guide.
- Sand that blocks the storm water sewers has been estimated to be 100 tons by Borough Engineers
- Debris in 3 local streams and about 10 acres of marshland was estimated by the PDW chief to be 5,000 CY

**Monitoring:** The estimated costs to monitor the remaining debris operations are based on current invoices submitted by O'Brien for the month of November. The applicant intends to continue to retain O'Brien to monitor the remaining debris operations at both the pick-up sites and the temporary staging sites.

**Contracts:** Contracts (attach copies, including any bid documents): The applicant's contracts with the Sakoulis, Devco, Apollo, Aurora, B&B Paving, 3 C's Backhoe, M&S Waste Services, Freehold Cartage, Mazza & Sons, Montecalvo, and Monmouth County Reclamation Center were not to exceed contracts with specific end dates. Contracts with R&B Debris LLC and Russell Reid were competitively bid pursuant to Borough policy.

**Competitively bid:** The applicant contracted with T&M Associates and Witt Associates and were approved by Council Resolutions and were chosen based on their particular expertise and experience in these situations. T&M Associates has frequently provided engineering services to the Borough in the past and was hired following the Borough's procurement principles. Witt Associates was hired based on the following: See Borough Resolution No. 2012-H012. "The Borough has pursued a membership in HGACBuy ( "Helping Governments Across the Country Buy") This is a local collective purchasing organization used nationally to obtain equipment and services that meet competitive purchasing requirements and authorizes Witt Associates to proceed with work with a "not to exceed" authorization of \$100,000.00, inclusive of expenses per terms of the governing contract.

**30-day period chosen (attach F/A spreadsheets):** FEMA Fact Sheet 9580.215 authorizes reimbursement of straight-time for 30 consecutive days. The applicant has chosen October 30, 2012 12:01am to November 28, 2012 11:59pm for their 30-day reimbursement of straight-time.

**Minimal Documentation:** The applicant did not have all their back-up documentation compiled at the time this PW was prepared. FEMA is estimating the costs and quantities related to both the work completed and the work to be completed. FEMA will revise this PW to adjust these amounts upon receipt and review of the applicant's documentation after the applicant completes all of their debris operations and provides all of the documentation to support their claim including, but not limited to, load tickets, contracts, task orders, bid documents, lease agreements, invoices, force account labor and equipment spreadsheets, timesheets, overtime policies, and permits. FEMA has not yet performed a review of the costs in this PW for reasonableness. In accordance with Title 44 Code of Federal Regulations § 13.36 (f), FEMA will review and determine whether the costs are reasonable when adequate price competition is lacking. In addition, the debris removal operations will be subject to further environmental review when the version is prepared with all of the specific details.

**Documents reviewed:** FEMA reviewed a sampling of the following supporting documentation which are attached:

- Load Tickets
- Permits
- Bid Documents
- Contracts
- Council Resolutions
- Invoices

This PW is for emergency work only; therefore mitigation is not eligible.

**DIRECT ADMINISTRATIVE COSTS: (Select one)**

- The Subgrantee requested Direct Administrative Costs (DAC) that are directly chargeable to this specific project. **PROCUREMENT:** The applicant is required to adhere to State Government Procurement rules and regulations and maintain adequate records to support the basis for all purchasing of goods and materials and contracting services for projects approved under the Public Assistance program, as stated in 44 CFR 13.36. The applicant has advised they have/will follow their normal procurement procedures.

**PERMITS:** The Project Specialist has advised the Applicant that it is their responsibility to obtain all applicable local, state, and federal permits prior to any construction or debris disposal activity referenced on this project. Applicant has also been advised that the lack of obtaining and maintaining these documents may jeopardize funding.

**INSURANCE:** The applicant is aware that all projects are subject to an insurance review as stated in 44 C.F.R. Sections 206.252 and 206.253. If applicable an insurance determination will be made as anticipated either proceeds or actual proceeds in accordance with the applicant's insurance policy that may affect the total amount of the project.
